Winter Quarter 2025: Course Descriptions

Undergraduate Courses:

BI102: The Historical Books – A study of Israel's history from Joshua to Esther. The historical significance of the period in its bearing upon proper understanding of the whole of divine revelation is given special attention.

GS114: Christian Witness - This course provides the student with the practical methods for the winning of the lost to Christ. It will equip the students to witness with grace and confidence. Emphasis is given to dealing with special problems and with the cults.

ST126: Doctrine of the Church – Ecclesiology is the doctrine of the church, which includes the time of its origin and conclusion and the revelation of the Body of Christ as it relates to the local church. Special emphasis will be given to the spiritual gifts as they relate to the government, offices and ministry of the local church.

BL128: New Testament Greek II - A detailed study of the elements of Greek grammar emphasizing the functional elements of the various parts of speech. Pre-requisite: BL128 – New Testament Greek I

CE144: Christian Education of Youth - An examination of the physical, psychological and cultural factors affecting the spiritual development of youth in relationship to their basic needs in today's society. Dynamics of staffing, programming, teaching methods and facilities are emphasized.

PM147 Pastoral Ministries 2 - This course explores the pastor's role in the church from their call to a local church and the role of pastoral care in the ministry. Areas of emphasis in pastoral care shall include effective ways of shepherding church leaders and laity and practical solutions to perplexing challenges in pastoral leadership.

Graduate Courses:

BI202: Bible Exegesis II: Prophetic Literature - In depth exposition of prophetic literature from the English text, focusing on outlining, common themes, and the differences between Old and New Testament prophetic passages.

BI207: New Testament Introduction - A study of the background of the New Testament, focusing on introductory problems, authorship and date of writing.

C. REFUND POLICY

RESIDENTIAL PROGRAMS

STUDENT'S RIGHT TO CANCEL

1. You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance.

- 2. Cancellation may occur when the student provides a written notice of cancellation at: 1712 Alcatraz Avenue, Berkeley, CA 94703 by hand delivery; 2000 Allston Way, Box 557, Berkeley, CA 94701 by mail; or email baycitiesbiblecollege@gmail.com.
- 3. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- 4. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- 5. If the Enrollment Agreement is cancelled the school will refund the student any money he/she paid, less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days after the notice of cancellation is received.

WITHDRAWAL FROM THE PROGRAM

You may withdraw from the school at any time after the cancellation period (described above) and receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. The refund will be less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days of withdrawal. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.
- The student has failed to attend class for three (3) consecutive weeks.
- The student fails to return from a leave of absence.

For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. The amount owed equals the daily charge for the program (total institutional charge, minus non-refundable fees, divided by the number of days in the program), multiplied by the number of days scheduled to attend, prior to withdrawal. For the purpose of determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of three (3) consecutive weeks.

If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

If any portion of the tuition was paid from the proceeds of a loan or third party, the refund shall be sent to the lender, third party or, if appropriate, to the state or federal agency that guaranteed or reinsured the loan. Any amount of the refund in excess of the unpaid balance of the loan shall be first used to repay any student financial aid programs from which the student received benefits, in proportion to the amount of the benefits received, and any remaining amount shall be paid to the student. If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.

Bay Cities Bible College reserves the right to change any provision of the catalog at any time. - 2. <u>Location:</u> All residential instruction occurs at the address checked on page 1 of this agreement. Distance education coursework is completed at a location determined by the student.
- 3. I understand that I will be awarded a degree when I have completed all of the program requirements. A graduate must have passed each course and have satisfied all financial obligations.
- 4. NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION: The transferability of credits you earn at Bay Cities Bible College is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the degree you earn in Biblical Studies, Pastoral Ministry, Christian Education or Christian Counseling at BCBC is also at the complete discretion of the institution to which you may seek to transfer. If the degree that you earn at this institution are not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Bay Cities Bible College to determine if your credits, or degree will transfer.
- 5. <u>Career Services</u>: Placement assistance is not provided. Our school cannot promise or guarantee either employment or level of income to any Student or Graduate.

- 8. <u>Financing</u>: The Student understands that if a separate party is financing his/her education, that the Student, and the Student alone, is directly responsible for all payments and monies owed to the school listed on this agreement.
- 9. <u>Books/Equipment</u>: All supplies for the program selected will be provided by the School at the stated charge. Lost, mutilated, or stolen items will be replaced at the expense of the student.
- 10. <u>Equipment Requirements</u>: We recommend that students have access to a computer with high speed internet access for research and a printer to print term papers. A webcam, microphone and speakers are also recommended to facilitate video conferencing.
