

Fall Quarter 2019: Course Descriptions

Undergraduate Courses:

BI104: The Major Prophets - A study of Isaiah, Jeremiah (including Lamentations) and Ezekiel. The books will be studied in their historical context and prophetic outlook. The great Messianic passages receive careful attention.

GS110: How We Got Our Bible - A concise and non-technical study of the essential areas of Old and New Testament Introduction. A short introduction to each of the books of the canon will be undertaken in the order of their appearance.

ST119: The Doctrine of God - The existence, nature and attributes of God are the subject of study. His decrees and works are studied. The Doctrine of the Trinity is proven from Scripture.

ST125: Doctrine of Salvation - The doctrine of salvation will be studied on the basis of the Biblical revelation. The death, resurrection and ascension of Jesus Christ will be considered as they relate to the unlimited scope of His work on the cross in its finished aspects.

BL131: Old Testament Hebrew I - The study of the Hebrew alphabet, grammar, vocabulary and sentence structure. Recommended: BI 109.

CE139 Educational Program of the Church - A study of the characteristics of a complete educational program in the local church. The student will develop an integrated Christian Education ministry, including Sunday School for all ages, club and small group activities, discipling and training programs.

CO154: Christian Counseling Applied to Individual Problems - Students explore and practice methodology of Christian counseling applied to problems encountered by individuals. Recommended: CO 152.

Graduate Courses:

BL228: New Testament Greek Exegesis I - Exegesis in the First Epistle of John, considering interpretive and theological problems. Emphasis on Greek syntax. Pre-requisite: BL128-130 or equivalent 1st year Greek course.

TH220: Introduction to Old Testament Theology - This course will include a discussion of the Biblical Theology movement and the differences between biblical and systematic theology, surveying major contributors to biblical theology. Students should be prepared to develop a proposal for biblical theology based on proper exegetical and hermeneutical principles.

C. REFUND POLICY			
RESIDENTIAL PROGRAMS			
STUDENT'S RIGHT TO CANCEL			
You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance.

- 2. Cancellation may occur when the student provides a written notice of cancellation at the following address: 1712 Alcatraz Avenue, Berkeley, CA 94703. This can be done by mail or by hand delivery.
- 3. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- 4. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- 5. If the Enrollment Agreement is cancelled the school will refund the student any money he/she paid, less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days after the notice of cancellation is received.

WITHDRAWAL FROM THE PROGRAM

You may withdraw from the school at any time after the cancellation period (described above) and receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. The refund will be less a registration or administration fee not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days of withdrawal. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.
- The student has failed to attend class for three (3) consecutive weeks.
- The student fails to return from a leave of absence.

For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. The amount owed equals the daily charge for the program (total institutional charge, minus non-refundable fees, divided by the number of days in the program), multiplied by the number of days scheduled to attend, prior to withdrawal. determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of three (3) consecutive weeks. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

If any portion of the tuition was paid from the proceeds of a loan or third party, the refund shall be sent to the lender, third party or, if appropriate, to the state or federal agency that guaranteed or reinsured the loan. Any amount of the refund in excess of the unpaid balance of the loan shall be first used to repay any student financial aid programs from which the student received benefits, in proportion to the amount of the benefits received, and any remaining amount shall be paid to the student. If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.
